PART I: GENERAL INFORMATION

“As the construction of Europe gradually shifts away from its initial focus (the market and the economy) and toward issues of high politics – currency, justice, foreign policy and (soon) defense – the need for “government” is becoming more critical. ... But the question is: What sort of government, and by whom?” Fraser Cameron\*

Course Description: At the end of October last year, the twenty five member states of the European Union signed the final, formal text of their new 350 page constitution. Ratification of that historical document is expected to take place during the next two years.

This course is devoted to an examination of the new constitution. The approach is based on a study of EU developments the last fifty years as the required bases for a detailed content analysis of the document with opportunities to interpret and speculate on its implications for future European integration.

After examining the general principles set forth in the opening part of the constitution, we proceed to study the new provisions for fundamental human rights. That is followed by a comparative analysis of the many “policy domains” as well as a careful discussion of the provision for a new institutional framework and a careful delineation of the division of power between central and state policy responsibilities. The general review of the constitutional provision is completed by examining the new external relations covering both common commercial policy and common foreign and security policies. We complete the course with a comparative analysis of prospects of the twenty five members ratifying the constitution.

Course Requirements: Regular attendance and active participation are especially important in a small seminar such as this and it will count for one fifth of the course grade. Instead of the conventional midterm, a number of short take-home exam essays (five or six) will be assigned as the semester progresses. Similarly, the final will consist of a thirty minute oral exam will be scheduled sometime on May 3<sup>rd</sup>. Everybody will be assigned a short term paper topic that will focus on the prospects of ratifying the constitution in the various member states. The assignments are given the following proportional value:
