

**SAS INSTITUTE, INC. PRODUCTS**  
**STUDENT, STAFF or FACULTY USE AGREEMENT**

In exchange for granting me as a registered student, staff or faculty in a degree-granting institution, the limited right to possess and use a copy of the copyrighted MicroIPPs (i.e., SAS for Windows or Macintosh and related Products such as SAS/STAT and/or SAS/FSP), I acknowledge and agree to the following:

- 1) Use of the MicroIPPs is governed by the License Agreement entered into by SAS Institute, Inc. and the Information Technology Services at the University of Southern California. The terms and conditions of that License Agreement apply to my use. Additional contractual information may be requested from and obtained from the Information Technology Services.
- 2) Neither I nor the Information Technology Services own the MicroIPPs or any copies thereof which are being provided to me.
- 3) I understand that the programs are licensed, proprietary, copyrighted property owned by SAS Institute, Inc. for which the Information Technology Services annually pays a license fee to enable it to make a limited number of copies available for use by employees or registered students of the university.
- 4) I understand that if I violate the terms of this Agreement, the University of Southern California has the right to take disciplinary action against me and that SAS Institute, Inc. has the right to take legal action against me.
- 5) I agree not to make any copies of the MicroIPPs for distribution to others or otherwise.
- 6) I agree not to allow access to the MicroIPPs by anyone except employees of the University of Southern California or registered students of the University in degree-granting programs who have executed this Agreement.
- 7) I agree that upon completion of my studies or when I am no longer a student, staff or faculty member, or when required to do so, for any reason, by the Institute or the University of Southern California, I shall return my copy of the MicroIPPs to the appropriate official of the university and delete any copies resident on hardware within my control that are located on the university's academic or administrative premises.
- 8) I agree not to reverse engineer or decompile the MicroIPPs.

SAS INSTITUTE, INC. WARRANTS THAT THE LICENSED SOFTWARE WILL CONFORM TO PUBLISHED SPECIFICATIONS, IF ANY, WHEN SHIPPED TO THE EDUCATIONAL INSTITUTION. SAMPLE DATA WILL BE SHIPPED WITH THE LICENSED SOFTWARE TO ASSURE THAT THE INSTITUTION HAS RECEIVED A VALID COPY. IT IS THE USER'S RESPONSIBILITY TO DETERMINE MACHINE COMPATIBILITY WHEN USING 'CLONE' ('COMPATIBLE') HARDWARE. CONTINUED OR FUTURE COMPATIBILITY WITH 'CLONE' HARDWARE IS NOT GUARANTEED. THE FOREGOING WARRANTY IS IN LIEU OF ALL OTHER WARRANTIES, EXPRESSED OR IMPLIED, INCLUDING BUT NOT LIMITED TO THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.

**Limitation of Liability:**

IT IS AGREED THAT SAS INSTITUTE, INC.'S LIABILITY HEREUNDER FOR DAMAGES, REGARDLESS OF THE FORM OF THE ACTION, SHALL NOT EXCEED THE MOST RECENT YEARLY CHARGES PAID BY THE EDUCATIONAL INSTITUTION FOR THE PARTICULAR LICENSED SOFTWARE PRODUCT(S) INVOLVED.

IT IS FURTHER AGREED THAT SAS INSTITUTE, INC. WILL NOT BE LIABLE FOR NEGLIGENCE OR ANY LOST PROFITS, OR FOR ANY CLAIM OR DEMAND BY ANY OTHER PARTY.

IN NO EVENT WILL SAS INSTITUTE, INC. BE LIABLE FOR CONSEQUENTIAL DAMAGES.
